## FARE RULES

<b>Flight Date/Time Change (Rebooking)</b>
a. Allowed for a fee 1,176 (including VAT; per passenger; per sector) plus any applicable fare difference between the current fare and the next available higher fare.
b. Fare difference and applicable fees must be paid before the changes can be finalized.
c. Downgrading of fare is NOT allowed.
d. Once confirmed, the rebooking fee is not refundable.
e. Rebooking is not allowed 24 hours prior to scheduled departure.
<b>Route Change (reroute)</b>
a. NOT allowed
<b>Flight Cancellation</b>
a. Voluntary Flight Cancellation is allowed for a fee to process and release refund; however, only the appropriate price of ticket purchased plus the corresponding government taxes and airport fees may be refunded but ancillary or add-on services purchased are forfeited
b. In cases of involuntary flight disruptions for reasons other than safety or security, rules stipulated under the Airline Passenger Bill of Rights will apply.
c. Cancellation within 24 hours prior to scheduled departure is subject to forfeiture of airfare.
<b>NO SHOW Penalty (at check-in; at the gate)</b>
a. Reservations cancelled; Fare forfeited.

## IMPORTANT REMINDERS (from full Terms and Conditions)

1. <b>RESERVATION:</b> No reservation shall be considered final unless a passenger purchases a Ticket.
2. <b>NON-TRANSFERABILITY OF TICKET:</b> A ticket is NON-TRANSFERABLE. It can only be used by the person whose name is indicated herein.
3. <b>CHECK-IN TIME:</b> Counter opens two (2) hours prior to departure time. Counter closes forty five (45) minutes prior to departure time. Your confirmed seat reservation will be cancelled and will be given to wait listed passengers if you fail to check-in forty five (45) minutes prior to departure time.
4. <b>FREE BAGGAGE ALLOWANCE:</b> Passengers holding PREMIUM and VALUE Fares are entitled to 20 kg and 10 kg Free Baggage Allowance respectively; NO Free Baggage Allowance for passengers holding BUDGET and PROMO Fares. Excess baggage weight will be charge Php 200.00 per kilogram.
5. <b>HAND CARRIED BAGGAGE:</b> Each passenger may hand-carry baggage as long as it does not exceed 7 kilograms with standard size of 18

inches (L) x 13.5 inches (W) x 9 inches (D) at maximum.

6. **BAGGAGE LIABILITY:** Guests are strongly advised not to bring valuable and fragile items as checked baggage. If guests check them in, the airline shall not be responsible for the damage to those items and that guests agree that the airline will carry them at guests own risk.

7. **LIMIT OF LIABILITY:** The liability of AirSWIFT under this Ticket shall not exceed the amount of US\$20,000 per passenger. It is agreed and understood that a passenger who requires a higher insurance coverage shall obtain the policy at his own cost.

8. **FORCE MAJEURE:** In case of fortuitous events or any conditions beyond the Carrier's control, no compensation shall be given if the flight for which the passenger holds a confirmed reservation is unable to accommodate him/her because (a) of government requisition of space, (b) the aircraft is substituted for another aircraft of lesser capacity due to operational and/or safety reasons depending on weather conditions and other causes beyond the Carrier's control.

9. **RIGHT TO REFUSE CARRIAGE:** The Carrier reserves the right to refuse any passenger to board the aircraft for valid reasons as reasonably determined by The Management.

10. **REFUND PROCEDURES:** A passenger can request for a refund provided that the unused Ticket are returned to the Carrier within one (1) year after the issuance of the Ticket. Corresponding cancellation and other processing fees shall be deducted from the total refund amount.

11. AirSWIFT is strictly a point-to-point carrier and shall not be responsible for any connecting flight arrangement which guest may choose to make. Guests are advised to plan any connecting flights accordingly.
